Pursuant to Executive Order No. 137, s. 1999 entitled *Declaring the Month of July of Every Year as National Disaster Consciousness Month and Institutionalizing the Civil Defense Deputization Program*, the Department of Education (DepEd), through the Disaster Risk Reduction Management Office (DRRMO), will lead in the observance of the **2015 National Disaster Consciousness Month (NDCM)** with the theme *Pamilya at Pamayanang Handa, Katuwang sa Pag-Unlad ng Bansa* in July.


