- The Department of Education through Region IV-A (CALABARZON) and Policy Research and Development Division, DepEd Central Office in cooperation with CALABARZON Regional Association of School Superintendents, and the Association of Learning Leaders in Region IV-A (ALLAA) will hold the 1st Luzon Conference of Basic Education Researchers with the theme: "Fostering a Culture of Research to Improve Educational Outcomes for Global Competitiveness", on October 27-29, 2015 at the Development Academy of the Philippines, Tagaytay City.

- 4. Interested researchers are encouraged to prepare and submit both for oral and poster presentation research abstracts to the official email address of DepED Region IV-A CALABARZON (region4a@deped.gov.ph) not later than August 28, 2015. Please note that all proposals must fall under the three strands of access, quality and governance. Research proposals, on-going research and completed research projects can be presented in this conference. All research papers presented during the Conference of CALABARZON Basic Education Researchers and in the National Research Conference held in Koronadal City are no longer eligible for presentation in this conference. Please refer to Enclosure 1 for the conference Guidelines.
- 5. A registration fee of Four Thousand Two Hundred Pesos (4,200.00) shall be collected from each participant including the presenters to cover breakfast (2), lunch (3), dinner (2) snacks (6), accommodations (2 nights) and other operating expenses. Expenses relative to this travel shall be chargeable against local funds subject to the usual accounting and auditing rules and regulations.
- 6. All participants are advised to pre-register through their respective Division officer/staff-in-charge of Research. The latter shall send the completed Registration Sheet (*Enclosure 2*) including the scanned payment receipt to the Registration Committee: Attn.: Dr. Melna R. Albano (melna aibano@deped.gov.ph) on or before September 30, 2015. Participants who prefer to register individually shall send the registration form and the payment directly to the conference secretariat. Walk-in participants shall not be allowed.
- 7. Immediate dissemination of this Memorandum is desired.

1" LUZON CONFERENCE OF BASIC EDUCATION RESEARCHERS GUIDELINES

- Teachers, researchers, school heads, education supervisors, interested researchers and graduate school students are qualified to present their paper to the said research conference. Only researchers should pre-identify the strand of their paper (Access, Quality and Governance).
- Research which have been presented in previous research conferences are no longer qualified to be presented in this conference.
- 3. Paper presenters are required to submit to the official email address of DepED Region IV-A CALABARZON (region4a@deped.gov.ph) not later than August 28, 2015 both oral and poster presentation research abstracts and one copy of the full version of their paper which shall not exceed 4,000 words (about 12-14 pages in double-spaced short size bond paper) using Arial font with a font size of 12. Enclosure 3 is the proposed template for the complete version of research papers.
- 4. Abstracts should consist of 150-200 words following the structured format:
 - Purpose (objectives of the research)
 - Design/methodology/approach (how the research will be conducted, includes sampling, mode of data collection, theoretical or subject scope of the paper)
 - Findings (results of the research, analysis of data, discussion)
 - Research limitations/implications (methodology parameters that can restrict the scope of the
 research findings and are outside the control of the researcher)
 - Originality/value (what is new in the research? what is the value of the research? is the
 research houristic or holistic?)
 - Keywords (listing of keywords will facilitate the search for the research work; should be italicized.
 - Type of Research (e.g. descriptive and/or inferential; quantitative and/or qualitative; basic or applied; experimental or non-experimental; action research etc.)
- 5. Paper presenters shall be guided by the following pointers:
 - a. Oral presentation shall last for 15-20 minutes with 10 minutes for open forum
 - b. The electronic copy of the presentation should be given to the Conference Secretariat at least 30 minutes before the presentation.
 - c. The presenters may distribute handouts/brochuzes in electronic and/or hard copies to interested participants. Schedules, changes thereto and venue of presentations shall only be made by the Conference Secretariat. The organizing committee shall have the right to all submitted abstracts and full version for publication in the research journal and for other research and development use.
- 6. For poster presentation: presenters are advised to use vertical (portrait) layout at 48x36 inches size. Poster should include the Abstract, Introduction, Research Questions, Research Design, Results and Discussions, Conclusions and References. Suggested font sizes: Title, 80-90 points; Authors, 50-60 points; Affiliation, 45-65 points; Headings, 40-50 points; Text, 30-40 points.
- 7. Presenters can indicate their preferred mode of presentation

- Notice of Acceptance to shall be sent to the researchers once their paper is qualified not later than September 15, 2015.
- Aside from the Certificate of Awards to be given to the winning presenters, cash prizes shall also be given to the three (3) best presenters of both oral and poster category. The decision of the board of judges shall be final.
