1. The Department of Education (DepEd) through the National Education Testing and Research Center (NETRC) shall administer the **School Year (SY) 2015-2016 Philippine Educational Placement Test (PEPT)** on November 15, 2015.
2. The venues for Cavite Province will be at **Trece Martires City Elementary School** with 1,010 examiners and at **Rosario Elementary School** with 105 examiners.
3. In preparation for the conduct of the test, there will be a Division Orientation on November 10, 2015 at Trece Elementary School from 1:00pm to 4:00pm. The participants will be the Principals of the concerned schools, Chief Examiners, Room Supervisors and Room Examiners who will serve in the conduct of the test.
4. The actual examination shall commence from 7:00am until 5:00 pm and the examinees should be at the testing venue on or before 6:30am in casual attire (no sleeveless and shorts) and should bring the following:
 - a. No. 2 lead pencil
 - b. Extra papers for scratch and computation purposes
