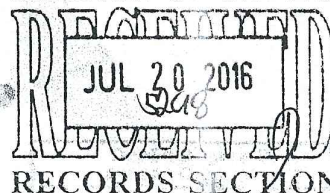

### Symposium

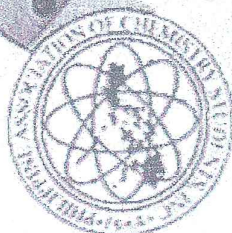

#### ORGANIZATIONAL PROFILE

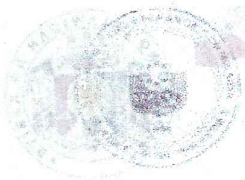
