





In light of the Regional Memorandum Circular No. 54, dated April 15, 2016 on the conduct of 2016 Principals Test, the National Technical Working Group herein provides updates on the application process.

CASE OF APPLICANTS

1. More than 21,000 online application forms and documents were received by the Regional Technical Working Groups led by the National Office - Quality Assurance Division (NO-QAD). The deadline for Steps 1 and 2 was July 1, 2016 at 12 noon. As stipulated in the CO-Circular 2016-01, the lengthiness of those who accessed the online application form along with the incomplete documents may require extension of the application period shall be determined by the NO-QAD.
2. Due to technical concerns experienced in several regions during Step 1, Validation Phase, the NO-QAD directed to include a regional memo to inform the list of indicated applicants (without the tracking number) per division on or before July 21, 2016 (Saturday). The NO-QAD shall send a copy of the said memorandum to the Regional Technical Working Group (RTWG).
3. Once the regional memorandum has been released, applicants may now proceed by submitting the following on or before August 12, 2016:
CHILDBORO (A copy of Formular 3 & 10 pictures with name tag and signature at the back taken within the last three months to the NO-QAD)
 1. Pay the registration fee of Five Hundred Pesos (P500) to the SDO Cashier (SDO shall issue an acknowledgement receipt)

The SDO Cashier shall turn over the collected registration fees to the NO-QAD and the SDO Personnel Section shall submit all the 210 pictures to the NO-QAD on or before August 16, 2016.
