## TERMS AND CONDITIONS

Prizes: 1 Champion per each category (3 Champions) – cash and certificate
1 from elementary
1 from Junior HS
1 from SHS

2 Runners-up from each category - cash and certificate

- The contest is open to all learners from elementary, Junior high school, Senior High School including Open HS, ALS, ALIVE and SPED.
- 2. Expected entries are:
  - 2 entries from each municipality for elementary level
  - 1 entry for Junior High School
  - 1 entry for Senior High School
- 3. Each participant should submit their entry observing the prescribed size and materials to use:
  - Elementary/ALIVE/ALS/SPED (14x14 Canvas) Acrylic Paint
     Junior High School / SHS/OPEN HS/ALIVE/ALS/SPED (36x24 Canvas-Landscape) Oil paint
- 4. All submitted entries shall become the property of the Division Office.
- 5. The name of the participant shall be duly acknowledged. Participants name and school should be written in the lower left corner of the painting.
- 6. The Division Office reserves the right to request the winners to further refine or make improvements and alterations on their paintings.
- 7. Entries will be judged on August 25, 2016.
- 8. Finalist will be displayed and judged again together with the public viewers' judgments with the 80/20% scheme, 80% from the judges and 20% from the public viewers on September 6, 2016.
- Entries must not contain any obscene or sexually explicit material factor that may initiate violence or may be abusive or disrespectful to the competition, groups or institutions. - 10. All entries must be original designs and unpublished entries. Plagiarized content from existing works is a ground for disqualification, and participants shall be held responsible for any problems that may arise with regard to questions of ownership or intellectual property.

Relevance to theme	25%
Overall Impact	15%

- 14. Violations to the above rules will lead to the disqualification of the entry.
