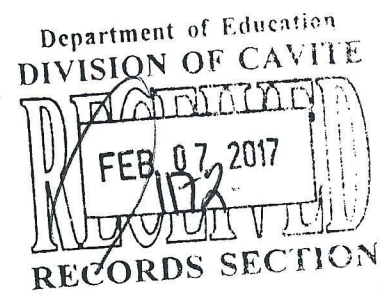

The insurance coverage shall commence on the date of membership. Coverage will be effective for a period of ONE (1) year from the date of membership and can be renewed upon renewal of membership with PRC.

Benefits

Bodily injury caused by violent, accidental, external and visible means which injury shall solely and independently of any other cause result in:

- Accidental loss of life
- Permanent total disability
- Permanent partial disablement
- Inclusion of unprovoked murder and assault
- Accidental medical reimbursement
- Accidental death burial assistance
- Hospital daily allowance

Extension of Coverage

- Acts of God
- Travelling in a public or public conveyance by land, air or sea as a fare-paying passenger and not as an operator or crew
- Riding as an operator or passenger of any two-wheeled motor vehicle with or without sidecar, except in the form of racing (motorcycling losses should not be in violation to any LTO regulations)
- Sabotage and terrorism
- Animal bites and insect bites (including mosquito bites – dengue only)

Note: Dengue is considered as accidental bodily injury which covers medical reimbursement and daily hospital allowance only are payable even with outbreak, hotspot, and clustering. Death is not covered and subject to a 30-day elimination period from date of membership.

Add-on Package

Group members can avail of the many services being offered by the chapter such as: First Aid Station, Community 143 Trainings, Mobile Blood Donation, Disaster Risk Reduction & Earthquake/Fire Drills, Youth Leadership Trainings, HIV/AIDS Prevention Education, and International Humanitarian Law Dissemination.

Termination Period

Coverage of the members shall automatically terminate without prior notice to PRC or to the Insured on the date the Master Policy terminates, whichever comes first.
