MECHANICS AND CRITERIA FOR JUDGING

I. Mechanics of entry:

1. Two school entries per unit (North, East, West, and South Unit) and so must screen by the unit coordinators.
2. Participants are allowed to use video editing computer softwares and digital video cameras.
3. Video entry total running time should be five (5) to ten (10) minutes, including front and back credits.
4. Video should be in mother tongue (Filipino or with subtitle if other dialect).
5. Entries should be saved in CD or DVD in MP4 format only.
6. Entry must be submitted to the Division Office of the EsP-EPS (c/o Sir Amel Zapanta) on or before July 24, 2017.
7. Film should be an original work of the EsP teachers and shall not infringe on any copyrights or any rights of any third parties.
8. Music and images presented in the film should be properly recognized and must be included in the credits part of the film.
9. Characters of the film must not exceed 15 persons of which may include the PTA and community participation.
10. All entries will automatically be owned by the EsP Department, DepEd Cavite, and will be used Instructional materials if relevant.
11. Top three (3) entries will be chosen as winners with TROPHIES and certificate of recognition based on the criteria for judging and non-winners will receive certificate of participation.

II. Criteria for judging:

1. Theme Relevance and Content – 30% (Story, Creativity, Originality, Coherence)
2. Technical Excellence – 30% (Visual creativity, Cinematography, Sound design, Editing)
3. Over All Quality – 40% (Relevance of the Issue, Meaningfulness, Value)

Quiz bee

1. Bawat municipality ay magpapadala ng (1) kalahok mula Grade 3 hanggang Grade 10.

(Each municipality will send 1 contestant per grade or year level from G3-G10.)

2. Dahil ito ay may National Quiz Bee ,ang Munisipality ay maaring magkaroon ng Municipal Meet o pagpili o assigned na kalahok na ipapadala sa Division Level Level Quiz Bee.

(Each Municipality is encouraged to have Municipal Contest for national Level preparation however, appointing contestants for the school is respected.)

3. Bawat kalahok ay makikipagtagisan hanggang final round. Ito ay may kategoryang Easy, Average and Difficult Round. Kung may tie ito ay babasagin sa pamamagitan ng clincher.

Each contestant will fight till difficult round.

4. Ang 3 mangunguna ay kikilanling Winners para sa 1st, 2nd and 3rd placer katumbas ng Gold, Silver and Bronze medals.

Winners will be recognized for 1st, 2nd, 3rd place for the Gold, Silver and bronze.

5. Ang bawat municipality ay magpapadala ng 15 tanong, 5 easy, 5 average and 5 difficult. Ang pagpapadala ay soft copy and hard copy na isusubmit sa EPS ng ESP. hanggang July 25 lamang. Ang mga tanong na hindi aabot sa takdang petsa ay hindi isasali sa mga tanong sa Tagis Talino.

(Each district in the elementary and each school in Secondary will submit 15 questions, 5 for easy, 5 for average, 5 for difficult. This is until July 25, 2017 only. Those who cannot submit until the deadlines will not be included in the pool of questions.)

6. Ang bawat kalahok at coach ay makatanggap ng sertipiko ng pagkilala gayundin ang mga magwawagi na siyang kalahok naman sa National Level Contest.

(Each coach and contestant will receive certificate of recognition as winners and certificate of appreciation for the contestants.)

7. Ang desisyon ng hurado base sa referensiya ay kikilanin siyang tama at hindi na mapasubalian. Ang protesta ng coach ay tatanggapin lamang ng chairman pagkatapos ng bawat round.

(Judges' decision is final. Written protest will be accepted by the grade level chairman after every round.)

General Guidelines for the Conduct of the Division Kindergarten Festival of Talents

1. Each unit shall conduct their own competitions to select the best contestants in all categories.
2. Participants to this competition are currently enrolled in Kindergarten.
3. A contestant is allowed to participate in only one category.
4. Each unit will have two entries per category.
5. Only the unit champions are qualified to join the contest.
6. On the day of the contest, coach in each category is required to submit
 - a. ID pictures (2x2)
 - b. certification from the principal that the child is currently enrolled in Kindergarten, &
 - c. parent's permit
7. There will be only one contest piece for storytelling.
8. Mechanics in the conduct of the contest per category is to be followed strictly.
9. Winners per category will be identified per criteria by the Board of Judges.
10. All winners will receive medals- 1st gold, 2nd silver & 3rd bronze and Certificate of Recognition.
11. The panel of judges shall be composed of a chairman and 2 members. The decision of the board of judges is final.

Specific Guidelines and Criteria for Judging

STORY TELLING

1. Contestants will be gathered in the assigned room.
2. Coaches and parents are not allowed to mingle with the contestant as the competition begins.
3. Each contestant will be given a maximum time of 5 minutes to deliver the piece.
4. The winner will be chosen by the panel of judges based on the general criteria below:

A.	Story Content	50 %

B.	Voice Projection/Verbal style	20 %
