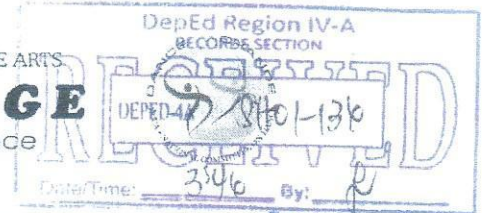




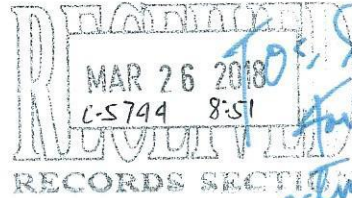

The National Commission for Culture and the Arts – National Committee on Dance is organizing **Dance Xchange: The Philippine International Dance Workshop and Festival** with the theme "Cultural Connectivity through Dance" on April 26 – 30, 2018 in Dumaguete City, Negros Oriental, Philippines.

The Dance Xchange aims to: 1) enhance knowledge and skills of the dancers, dance teachers and choreographers on dances of the different countries as creative expression of their culture, 2) strengthen network among dance groups from the different countries, 3) showcase the unique dances of each country to enhance cultural understanding, 4) provide them with new ideas and inspiration which will stimulate the creativity of choreographers and dance directors, dancers and dance teachers; and 5) provide platform for discussion on the global trends on dance education and of dance as tool for global connectedness.

The Dance Xchange will have activities such as artists' forum, *dance workshops to be conducted by foreign dance directors from participating countries for teachers, festival and management workshops*, festival of dance performances, and outreach performances. The NCCA is coordinating with TESDA for certification on Events Management (NCIII) and Performing Arts (Dance NCII) as part of the festival.

In line with this, we would like to request for your support and assistance for the participation of the MAPEH teachers, SPA teachers, teachers of the Arts and Design Track, dance director, events organizers and managers, dance trainers and choreographers to participate in the Dance Xchange. A registration fee of **P2,000** will be charged to cover the expenses for the kit, T Shirt, certificates, ID, production of materials and other expenses. *This does not include food, accommodation and transportation of the participant.*

**DANCE XCHANGE: THE PHILIPPINE INTERNATIONAL DANCE
WORKSHOP AND FESTIVAL**

1. The National Commission for Culture and the Arts (NCCA)-National Committee on Dance will conduct the **Dance Xchange: The Philippine International Dance Workshop and Festival** from April 26 to 30, 2018 at the Lamberto L. Macias Sports and Cultural Center, Dumaguete Convention Center, Dumaguete City, Negros Oriental.

2. The Dance Xchange aims to:

- a. provide enriching activities for choreographers, physical education (PE) or MAPEH teachers, from the Special Program for the Arts (SPA) and Arts and Design Track of the Senior High School (SHS), dance trainers and learners;
- b. provide them with new ideas and inspiration which will stimulate the creativity of choreographers and dance directors and dancers, and dance teachers;
- c. showcase the unique dances of each country;
- d. strengthen the network among international dance organizations towards stronger cultural relations among participating countries;
- e. give the participants an opportunity for interaction and learning among dancers, directors, and dance choreographers from the different countries, including the Philippines; and
- f. utilize dance as a tool for cultural exchange and sharing.

4. The Dance Xchange will have activities such as dance conference, dance workshops to be conducted by directors of the participating countries, festival of dance performances, major concerts, outreach performances, master classes for dancers and cultural tours.

5. The participants to this activity are MAPEH and SPA teachers, teachers of the Arts and Design Track of SHS, dance trainers, choreographers, and directors of dance groups in schools, and dancers. The attendance of public school teachers and personnel shall be **on official business**.

6. A registration fee of Two Thousand Pesos (P2,000.00) will be charged to the school's Maintenance and Other Operating Expenses (MOOE) to cover expenses for kits, seminar bags, IDs, certificates, t-shirt, and other resource materials. Travel, food, and accomodation shall be at the expense of the participants.
