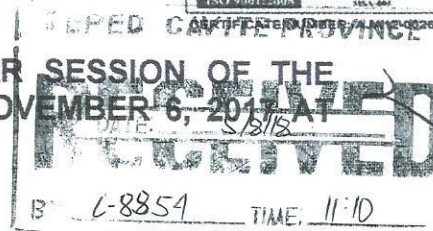

**WHEREAS**, the Provincial Government of Cavite recognizes the integral contributions of General Emilio Aguinaldo to the evolvement of Philippine Government, most especially his heroic legacy in Philippine Independence, national flag, national anthem, his competence in marking our national history for his immense dedication and nationalism for the country;

**WHEREAS**, the Provincial Government of Cavite supports the commemoration of the life of Caviteños pride and honor, General Emilio Aguinaldo, to remember his heroic life, sacrifices for one's country towards its independence, contributions to the Government and devotion in aiming for the betterment of the Filipino people;

**NOW, THEREFORE**, on motion of Hon. Varias, duly seconded by Hon. Lara and all the members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

**Section 1. Short Title.** This Ordinance shall be known as the "*Province of Cavite's Sesquicentennial Birth Anniversary Commemoration of General Emilio Aguinaldo*".

**Section 2. Governing Policies.** The Province of Cavite and all public and private schools, institutions, colleges and universities subscribe to the following policies:

1. That all public and private schools, institutions, college and universities within the Province Of Cavite are hereby mandated to commemorate the 150<sup>th</sup> birth anniversary of General Emilio Aguinaldo by disseminating reading materials and/or conduct of relative school activities pursuant to the herein purpose.
2. That all local government units within the Province of Cavite are likewise mandated to take part in the herein commemoration and shall ensure that all schools, institutions, colleges and universities within their jurisdiction have complied with the herein ordinance.

**Section 3. Repealing Clause.** All ordinances, resolutions, executive orders, rules and regulations, other issuances, and parts thereof, which are inconsistent with the provisions of this Ordinance, are hereby repealed and modified accordingly.

**Section 4. Separability Clause.** Should any provision herein be subsequently declared invalid or unconstitutional, the same shall not affect the validity or the legality of the other provisions not so declared.

**Section 5. Effectivity.** This Ordinance shall take effect after its approval and compliance with the posting and publication requirements.




