2018 ADMINISTRATION OF THE SPECIAL PHILIPPINE **EDUCATIONAL PLACEMENT TEST**

- In reference to DepEd Advisory dated May 29, 2018, this Division will administer the Special Philippine Education Placement Test, on June 10, 2018 at Trece Martires City Elementary School, San Agustin, Trece Martires City Cavite.
- Pursuant to DepEd Order 55, s. 2016, the Philippine Educational Placement Test (PEPT) may be administered to the following:
 - a) Learners from schools without a government permit.
 - b) Learners from nonformal and informal education programs.
 - c) Learners who have incomplete or no record of formal schooling.
 - d) Learners with back subjects.
 - e) Learners who need grade level standards assessment.
 - f) Learners who are overage for their grade levels.
- The requirements for taking the PEPT are the following:
 - a) Form 137 or Form 138 duly signed.
 - b) 1x1 identical id pictures 2 pcs.
 - c) Birth Cettificate.
 - d) Duly Accomplished PEPT form. (white form attached to this)
- 4. The submission of requirements will be up to Thursday, June 7, 2018 at 5 pm. care of Miss Norie Vasques.
- 5. The supposedly test takers last June 2, 2018 can still take the PEPT using the updated FREE WHITE FORM with updated requirements if still needed.
- 6. It is highly requested that the School Heads in public and private schools through the PEPT in charge in schools or guidance counselors should orient the examinees for test and secure protective measures in going to testing center.

- 7. The actual examination shall commence from 7:30 am until 5:00 pm and the examinees should be at the testing venue on or before 7:00 am in casual attire (no sleeveless and shorts) and should bring the following:
 - a) No. 2 lead pencil
 - b) Extra papers for computation purposes
 - c) Snacks and lunch
- 8. In order to achieve the smooth conduct of the test, there will be an orientation of room examiners and evaluation of papers and testing task force held on June 8, 2018, 2:00 pm at Tanza National Trade School
- 9. Education Program Supervisors and Public Schools District Supervisors are requested to monitor the conduct of the and PEPT.


