- 3. Newly LET passers may apply but in lieu of their Report of Rating, they shall have to submit the Certificate of Good Standing issued by the Civil Service Commission.
- 4. Those who were not included in the RQA in Batch 1 and 2 for SY 2018-2019 may update their scores to the respective schools they applied in.
- 5. Schools shall include all Batch 1 and 2 applicants without EPT and interview in the summary of ranking for additional Batch 2 applicants.
- The submission of the summary of ranking is STRICLTY by Municipality/District only.
- 7. In addition to, respective Municipal HR Coordinators shall review and validate the completeness of the documents and the accuracy of the data in order to facilitate smooth work flow procedure.
