By sending an entry and therefore participating in HISTORY BEE contest, each participant agrees to follow these Official Rules and to be bound by any decisions made by A&E NETWORKS ASIA (the "Channel") including any interpretations of these Official Rules.

TO ENTER:

- 1. History Bee is open to high school and college students in private and public educational institutions in Metro Manila, Region 4A.
- 2. Contestants must be citizens or legal residents of the Philippines.
- 3. Contestants must be enrolled in the current school year 2018-2019.
- 4. There is no registration fee for all participating students. Contestants can register online the link:

- Contestants in the High School Category who register will likewise be asked to accomplish, scan and send via email the Principal's Endorsement Letter and Letter of Consent from the parents to: historybee2018@gmail.com.
 - Qualified registrants in the High School Category are required to bring original copies of these letters during the contest proper. Qualified contestants in the College category are required to present their college registration form. In case the contestant is a minor below 18 years of age, they are required to submit a parental consent form.
- Deadline for registration is on <u>August 03, 2018</u>. Only registrants of the High School Division who have submitted the required Principal's endorsement letter and parental consent form (including College registrants below the age of 18) will be accepted.
- 6. The contest will be divided into two (2) groups:

High School Category / Asian History, World History, and Culture

- Junior High School (Grades 7 to 10)
- Senior High School (Grades 11 to 12)

College Category/ Philippine History and Culture

7. The participating schools in the High School Category will only be allowed to register a maximum of two (2) students.

For the High School Category, the school may opt to:

- a. have Two (2) contestants from the Junior High School, or,
- b. One (1) contestant from the Junior High School and One (1) from Senior High School, or,
- c. Two (2) contestants from the Senior High School.
- 8. The College Category will be by individual participation.
- 9. Substitution of contestants will not be allowed after August 03, 2018.
- 10. High School Category Contestants are required to wear their school uniform and school ID during the contest proper.
- 11. Contestants should be at the Event Venue at least 1 hour before the start of the contest.
- 12. The contest will be in two (2) rounds, namely: qualifying round and the final rounds. Contest schedule will be as follows:

12. The contest shall cover the following topics:

Asian History, World History, and Culture (High School Category)

Pop culture and current events, Philippine History and Culture (College Category)

- 13. All qualified registrants (those who have completed the registration requirements) shall participate in the Qualifying Round.
- 14. Only contestants, members of the Board of Judges, checkers and proctors, duly authorized representatives of the organizers, and DTI representatives will be will be allowed inside the examination room during the qualifying round. Use of any communication device such as phones, tablets, laptops and two-way radio is strictly prohibited.
- 15. Proctors are assigned to ensure the smooth and orderly conduct of the exam and are authorized to call the attention of examinees that disturb the examination proceedings. Students caught engaged in any form of cheating shall immediately be escorted out of the examination room and will be disqualified.
- 16. Contestants that garner the top ten (10) scores in the High School category, regardless of school, shall proceed to the Final Round. In case of a tie for the 10th slot, a tiebreaker exam will be given.
- 17. Contestants that garner the top ten (10) scores in the College category, regardless of school, shall proceed to the Final Round. In case of a tie for the 10th slot, a tiebreaker exam will be given.
- 18. The Final Round will be a live quiz show format, where questions shall be read and announced by a quizmaster. The Final Round will be open to the viewing public. Coaches and advisers of the students are advised to occupy the designated place at the event venue. The audience is expected to maintain silence during the conduct of the Final Round. The organizers reserve the right

to escort audience members who disrupt the quiet conduct of the Final Round. Cheering and applause will only be allowed during the announcement of the finalists.

- 19. The student with the highest score will be declared the First prize winner, with the second and third highest scoring students will be 2nd and 3rd place winners respectively.
- 20. The results of the examination/ contest as proclaimed by the Board of Judges will be final and executory with prior approval of DTI. All test materials and original outputs of the examination/contest will be provided by History and considered property of History and will be preserved for documentation purposes.

 There will only be one (1) History Bee Grand Champion per category. The Grand Champion will be announced on the event venue and will be selected and notified by three (3) Board of Judges, namely:

A representative of Department of Trade and Industry in the event venue shall witness the declaration on August 11, 2018. The History Bee Grand Prize winner selection will be based on the highest point accumulated from the Final Round.

- 2. The Grand Champion is highly encouraged to be present during the awarding.
- The decisions of designated Board of Judges with the consent of DTI shall be final and binding on all aspects of the contest.
