2018 ADMINISTRATION OF REGULAR PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

OIC, Assistant Schools Division Superintendents TO: Chiefs, CID and SGOD Education Program and Public District Supervisors Secondary and Elementary School Heads **Guidance Counselors PEPT Test Administrators**

- 1. With reference to DepEd Order No. 025, s. 2018, this Division will administer the Philippine Education Placement Test on November 18, 2018 at Trece Martires City Elementary School, San Agustin, Trece Martires City.
- 2. Pursuant to DepEd Order 55, s. 2016, the Philippine Educational Placement Test (PEPT) MAY BE ADMINISTERED TO THE FOLLOWING:
 - a. Learners from schools without government permit.
 - b. Learners from non formal and informal education programs.
 - c. Learners who have incomplete or no record of formal schooling.
 - d. Learners with back subject from previous PEPT within six months after its release.
 - e. Learners who need grade level standards assessment,
 - f. Learners who are overaged of their grade level.
- 3. The actual examination shall commence from 7:30am to 5:00pm and the examinees should be at the testing venue on or before 7:00am in casual attire (no sleeveless and shorts) and should bring the following: Lead Pencil (No. 2), Extra papers for computation purposes, Snacks/Lunch.
- 4. It is highly requested that the PEPT coordinators in different districts should inform the examinees as to testing center, Trece Martires City Elementary School.
- 5. In order to achieve the smooth conduct of the test, there will be an orientation of the Room Examiners and Testing Task force on November 16, 2018, 8:30 am onwards at Silid Ugnayan, DepEd Compound, Trece Martires City.
- 6. Immediate dissemination of this Memorandum is highly expected.


