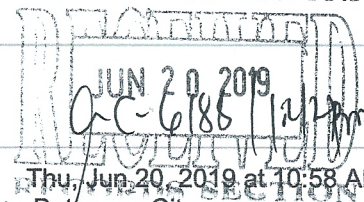

## UNFIT BANKNOTE

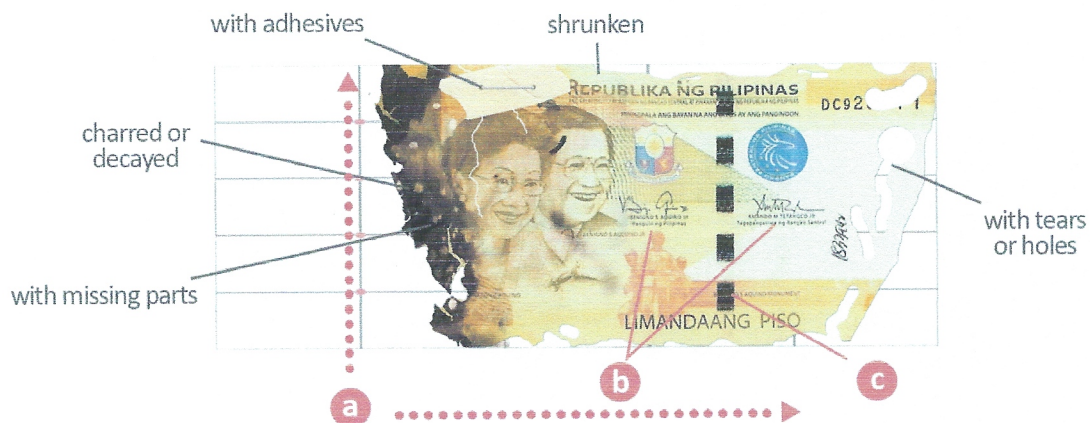
has ANY ONE of the following:



**!** Shall be exchanged with any bank

## MUTILATED BANKNOTE

has ANY ONE of the following characteristics:



**!** Shall be submitted to ANY bank for analysis of the Bangko Sentral ng Pilipinas

Mutilated banknotes can be exchanged with the Bangko Sentral ng Pilipinas if they have the following:

- At least 3/5 of the surface area;
- A portion of any of the facsimile signatures; and
- Embedded or windowed security thread.
