

- 1. The SDO Cavite Province, Office of the Assistant Schools Division Superintendent is in the period of health profiling of all division personnel for the basis of appropriate division health programs and initiative to strengthen health advocacies and campaigns as mandated by DepEd Memorandum No. 22, s. 2015 which states that all Department of Education, teaching and non-teaching personnel shall undergo annual physical examination in compliance with the Civil Service Commission Memorandum Circular No. 17, s. 1989.
- 2. In order to attain such objectives, all division personnel are hereby required to visit the Division Health Unit on schedule specified below for actual **HEALTH PROFILING**, which includes:
 - a. Cardiovascular Disease risk assessment
 - b. Height and weight taking
 - c. Demographic data interview
 - d. Health history taking, and
- e. Completion of Annual Physical Examination (APE) requirements (Chest X-ray, Urinalysis and Complete Blood Chemistry), for those who have not yet submitted their APE results.
- 3. Data that will be gathered shall be analysed and used as baseline information for research-based policy making efforts, creation of an environment that promotes health of all employees, strengthening community action, development of personal skills and reorientation of health services.
- 4. The Medical Unit shall facilitate the aforementioned activities from 8:00 am 5:00 pm according to the schedule listed below:




