## **2019 CAVITE COOPERATIVE MONTH CELEBRATION MUNICIPAL KOOPQUIZ FOR GRADE 10 STUDENTS**

### **OBJECTIVES:**

1. To provide the schools particularly the students an avenue for learning in the field of cooperatives.
2. To bring awareness on the significance and contribution of Cooperatives in social and economic development in the countryside.
3. To be able to inculcate the principles and practices of cooperative among students.
4. To be able to influence the schools and the students in enterprise development through cooperatives.

### **GENERAL GUIDELINES AND MECHANICS OF IMPLEMENTATION**

1. The KOOPQUIZ shall be facilitated by the Provincial Cooperative Livelihood and Entrepreneurial Development Office (PCLEDO) in partnership with Provincial Cooperative Development Council.
2. There may be a municipal/city level contest, which shall serve as the elimination round or the First Level Competition or Local CDCs may tap one student who will represent their municipality or city.
3. The competition shall be participated by Grade 10 (10) students from public and private schools in the province.
4. The Municipality/City Cooperative Development Office shall submit the name of the official representative using the prescribed entry for not later than October 4, 2019.
5. The student-contestants shall wear their respective school uniforms during the contest proper. They shall be provided with coded numbers.
6. Each student shall be allowed to have one (1) adviser who will be officially recognized as his/her consultant.
7. The provincial winners shall be declared and shall receive the following:  
**KOOPQUIZ WINNERS**

KOOPQUIZ Champion	-	TROPHY/Medal + P 10,000.00
KOOPQUIZ 1 <sup>st</sup> Runner-up	-	TROPHY/Medal + P 6,000.00
KOOPQUIZ 2 <sup>nd</sup> Runner-up	-	TROPHY/Medal + P 4,000.00
8. All official advisers and Municipal/City Cooperative Officers/Coordinators will be given Certificates of Citation/token of appreciation.





### SPECIFIC GUIDELINE:

1. All questions shall revolve around COOPERATIVE matters.
2. The questions shall be categorized and given points as follows:

3. The set of official questions shall be provided by the Cooperative Development Authority and shall be turned-over to the PCLEDO officers-in-charge of the elimination round.
4. All questions shall be in English.
5. The contestants shall be given time limit to answer each question.
6. The contestants shall be evaluated based on points garnered. The highest score shall be declared winner and shall represent the Provincial LGU to the regional championship round.
7. In the event of tie, three (3) difficult questions shall be asked and the results shall determine the ranking. In case of ANOTHER TIE , KNOCK OUT SYSTEM shall be applied. The question shall be drawn from the set of clinchers.
8. There shall be a Board of Judges (BOJ) to determine the accuracy/validity of the answers of the contestants.
9. Protest/s on questions, and questionable answer shall be immediately brought to the attention of the Board of Judges before the next question is tackled for immediate resolution. No questions/protests on previous questions, answers and decisions shall be entertained. The decision of the BOJ shall be final.
10. Only the contestant/official Coach can raise a question of protest.
11. For those who will conduct the first level competition: The Municipal/City LGU shall be CLOSELY COORDINATED by the CDS of CDA and shall handle the following
  - a. Information dissemination and invitation of School participants;
  - b. Provision of the requirements for the competition; venue, supplies, quiz master, board of judged foods, prizes, etc
  - c. Adoption of its own scheme in the conduct of the contest proper, but shall not be in conflict in general guidelines;
  - d. Set-up for practical, appropriate and responsive arrangement in all stages of the implementation of activity.
