

- 6. Expenses of the student writers, coaches, trainers, facilitators and monitoring teams relative to this INCLUDING THE PUBLICATION OF THE SCHOOL PAPERS can be charged to school MOOE, canteen fund and other local funds.
- 7. In lieu of the services rendered, the concerned school heads and teachers shall be given compensatory leave and/or service credit, whichever is applicable.
- 8. School heads shall ensure that class schedule of winning coaches, trainers and facilitators is adjusted to meet the required contact time of the week or arrangement with other teachers to take over their classes has been made.
- 9. It is reiterated that the RSPC qualifiers' participation in the cliniquing and other pre-RSPC activities, in NO INSTANCE, shall affect their class performances in any form, therefore school heads, class advisers and other subject teachers are instructed to guard the grades of the student contestants.
