Based on the result of the 2019 Annual Physical Examination, which was conducted during the 2nd quarter of this SY, majority of the detected ailments are considered as lifestyle-related diseases, affected with multifactorial reasons such as environment, nature of work, exposure to triggers, weakened immune system, stress-induced and genetics. Nevertheless, most of those are modifiable diseases. Moreover, a local research that dealt with the Health-Seeking Behavior of teaching personnel in the District of Tanza was conducted last August 2019 revealed that almost all teaching personnel resort to health seeking behaviors.

2. Anent to this, there will be an **Orientation and Capacity-building on Health Seeking Behavior and Project H.E.A.L.T.H.** on **December 4-6, 2019** at the **Bayleaf Hotel and Resort, General Trias City, Cavite** for selected DepEd Cavite SDO personnel. - create awareness on health seeking behavior and practices
- guide participants in identifying correct and appropriate interventions to handle illnesses
- encourage participants to apply correct approaches in treating and handling illnesses
