(ABM) STUDENTS**

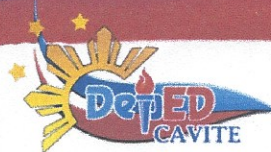

1. Pursuant to Republic Act No. 11206 (An Act Establishing a Career Guidance and Counseling Program), this Office announces the conduct of a **two-hour Career Orientation Seminar for selected Accountancy, Business, and Management (ABM) students** on **January 26, 2020 (Sunday), 12:00 n.n. to 3:00 p.m.**, at the **Rogationist College, Silang, Cavite**.
2. Organized by the Philippine Institute of Certified Public Accountant (PICPA), the event targets ABM students who will pursue college education under the BS Accountancy program. These students shall also be given free basic accounting books and calculators.

4. Student participants shall secure and submit a signed waiver or guardian's/ parent's permit upon their attendance to the said event. They shall be acquainted with the school career guidance coordinator. In the event of the career guidance coordinator's unavailability, the participants' teacher adviser or other qualified alternate may accompany them.

5. Teacher participants shall be rewarded with service credits consistent to the provisions of DepEd Order No. 53, S.2003 while non-teaching personnel shall be rewarded with compensatory time-off.
6. The final list of participants shall be issued through a separate memorandum upon the completion of the pre-registration. Slot of pre-registered participants is strictly **not transferrable**.
7. Transportation and other relevant expenses may be charged against school local funds subject to the usual auditing and accounting rules and regulations.
