GUIDELINES ON THE CONDUCT OF ONLINE DFSPG AND DFSSG ELECTIONS FOR SY 2020-2021


- 1. The online Division Federation of SPG and SSG election shall be participated by all qualified District-elected SPG presidents and qualified elected SSG Presidents for S.Y.2020-2021. To qualify, participating schools must have a school ID number, hence, officers of any school with no school ID yet are not allowed to run or vote.
- 2. All District-elected SPG presidents must joined the DFSPG Election SY 2020-2021 Private Facebook group at bit.ly/2Br9r8F while All elected SSG presidents must joined the DFSSG Election SY 2020-2021 Private Facebook group at bit.ly/2YVawyl Only qualified participants shall be allowed to join. But in order to assist and guide the District elected SPG presidents, their respective advisers are also encouraged to join the DFSPG Election SY 2020-2021 Private Facebook group.
- 3. On creating Party Lists and Nomination of Electoral Candidates, the participants shall consider the following:
 - 3.1 For DFSPG Election, participants must form two (2) party list composed of one candidate for the following positions: President, Vice-President, Secretary, Treasurer, Auditor, Public Information Officer, and Peace Officer. The remaining participants and seven (7) unelected electoral candidates shall automatically be included in the DFSPG as cluster representatives (All District-elected SPG presidents have a secured spot in the Division Federation). Hence, cluster representatives' names will no longer be included in the online polling platform. The candidates shall be democratically and unanimously elected or selected by their respective group members.
 - 3.2 For DFSSG Election, participants are grouped into three (3) and each group must be represented by a party list composed of one candidate for the following positions: President, Vice-President, Secretary, Treasurer, Auditor, Public Information Officer, Peace Officer, North Cluster Representative, South Cluster Representative, East Cluster Representative, and West Cluster Representative. The candidates shall be democratically and unanimously elected or selected by their respective group members.







- 4. Once selected, each candidate should submit a soft copy of their recent 2X2 photograph, signed certificate of candidacy and parental consent (printed or handwritten) to depedcavite.yfd@deped.gov.ph COMELEC must evaluate the certificate of candidacy and must announce the official list of candidates. Moreover, each official party list/candidates must comply with the following:
 - 4.1 The name of the party list must observe and consider a nationalistic theme.
 - 4.2 Each party list must produce a campaign video (2-5 minutes only) and poster (JPEG/PNG format) for the whole party list and for individual candidates.
 - 4.3 All campaign materials shall bear the Name of the party list and the candidates. Video campaign ads shall briefly discuss the party list's and individual platforms and their Action Plans in a monthly basis
 - 4.4 All the campaigns materials must be submitted within the scheduled date to depedcavite.yfd@deped.gov.ph
 - 4.5 Only the FB group admin (DepEd Cavite Youth Formation Coordinators) shall be allowed to upload the said materials on the online platform as scheduled.
 - 4.6 Campaign materials shall be posted in the official FB group created for the Division Federation elections as scheduled.
 - 4.7 Candidates may also opt to post their campaign materials through their declared official Facebook account, but the following limitations/instructions must be observed:
 - 4.7.1 Posting using their official Facebook account is allowed but not required.
 - 4.7.2 Using other social media applications other than Facebook on posting their campaign video and poster are not allowed.
 - 4.7.3Campaign materials to posted must be the same on what is submitted to and approved by YFC's and COMELEC
 - 4.7.4 Posting must follow the scheduled date set by the COMELEC and YFC's and must include the hashtag #SSGCavFedElections2020 for DFSSG and hashtag #SPGCavFedElections2020 for **DFSPG** respectively.
- 5. To further assist the voters in selecting the best candidates for the DFSSG Election,



topics shall be assigned for each candidate who shall record their insights or stand in a 30-second video speech.

- 5.1 Videos shall be submitted to depedcavite.yfd@deped.gov.ph and shall be posted by the FB group admin as scheduled. The 30-second videos are **strictly not allowed** to be posted on their personal Facebook accounts.
- 5.2 Voters are encouraged to air their reactions and comments but shall not post any rude feedback against any of the candidate. Reactions shall have no bearing to the results of the elections.
- 6. Voters may cast their votes using their official email account. Only one vote per official email address shall be registered and honored. Voting shall last for three days to give voters ample time especially those who have weak Internet connection/access. The link to access the polling platform shall be send to their registered official email address a day before the election.
- 7. The Division Youth Formation Coordinators shall serve as Commission of Election (COMELEC) and shall have the following responsibilities:
 - 7.1 Conduct pre-registration of qualified voters
 - 7.2 Evaluate the Certificate of Candidacy
 - 7.3 Announce the official list of candidates
 - 7.4 Create polling platform. An alternative mechanism shall be prepared for voters who do not have Internet access
 - 7.5 Ensure that only pre-registered voters will have access to polling platform
 - 7.6 Monitor and consolidate polling results
 - 7.7 Present the election turnouts and proclaim the winning candidates
 - 7.8 Facilitate the oathtaking ceremony
- 8. Teacher advisers of the elected candidates shall occupy the same position of their respective students.
- 9. The results of the elections are irrevocable. And due to the threats of COVID-19, oath taking ceremonies shall also be conducted online. Winning candidates shall sworn to office as scheduled and shall serve for the whole duration of S.Y. 2020-2021.

- 1. The School Head (SH), upon the proposal of the members of the SPG/SSG Commission on Elections (COMELEC) with the recommendation of the SPG/SSG COMELEC Chairperson, may also issue additional guidelines on the SPG/SSG COMELEC Standard Election Code consistent with the Constitution and By-Laws of the SPG and SSG in elementary and secondary schools, to ensure the fair and successful conduct of the elections.
- 2. The SGOD Chief and the Division Youth Formation Coordinator (PDO I) shall conduct the election of the Division Federation of SPG and SSG Officers on March 9, 2020 and shall submit to the Youth Formation Division (YFD) the result of the Division Federation elections using the attached Enclosure No. 1.
- 3. The Regional ESSD Chief and the Regional Youth Formation Focal Person (PDO IV) shall conduct the election of the Regional Federation of SPG and SSG Officers on March 23, 2020 and shall submit to YFD the result of the Regional Federation elections using the attached Enclosure No. 2.
- 4. The elected SPG/SSG officers during the oath taking ceremony shall undergo a parallel school-based training on basic skills of leadership, roles, functions, and responsibilities of each office using the modules of the Student Leadership Development Program (SLDP) and Nation of Heroes. The newly-nominated SPG/SSG Adviser shall supervise the implementation of the said training, in cooperation with the previous SPG/SSG officers and adviser.

Expenses to be incurred shall be charged to school MOOE, subject to the usual accounting and auditing rules and regulations. All plans and programs of the SPG/SSG shall be incorporated in the School Improvement Plan and Annual Improvement Plan.


