2020 NATIONAL DISASTER RESILIENCE MONTH

1. Relative to Executive Order No. 29, s. 2017 which mandates all national government agencies to observe National Resilience Month for the whole of July of every year, this office would like to enjoin all schools to participate in this nationwide campaign of building disaster resilience at all levels with the theme: "Sama-samang Pagsulong Tungo sa Katatagan sa Gitna ng Bagong Normal". This year's NDRM observance focuses on strengthening disaster resilience in the country while adapting towards the "new normal" caused by the COVID-19 pandemic.
2. Various NDRRMC member-agencies are expected to launch activities for the month-long celebration; albeit most will be done online due to the ongoing COVID-19 situation.
3. As part of the celebration, schools are expected to undertake relevant activities which emphasize Disaster Risk Reduction and Management (DRRM) education such as, but not limited to the following:
 - a. Posting of National Disaster Resilience Month signage in schools and official social media pages;
 - b. Improvement of handwashing facilities in schools;
 - c. Disinfection of school facilities and classrooms;
 - d. Posting of COVID-19 safety measures in schools;
 - e. Conduct of various wellness and psychosocial support services to teaching and non-teaching personnel and;
 - f. conduct of related activities to ensure heightened awareness, consciousness and mitigation among school administrators, teachers, personnel, parents and school children.
