**REGISTRATION FOR THE ADMINISTRATION OF THE
2020 COMPUTER-BASED ACCREDITATION AND EQUIVALENCY (A&E) TEST**

1. This is with reference to the concluded Coordination Meeting held last October 27, 2020 by the Bureau of Education Assessment relative to the conduct of Computer-based Accreditation and Equivalency Test.
2. Relative to this, applicants who opt to take the CB-A&E may register from October 29 – November 5, 2020 at the respective municipality where they completed their ALS Program.
3. The following shall be the registration and Guidelines of the 2020 CB-A&E Test:
 - a. Priority shall be given to those applicants who are temporarily enrolled in the formal school. They also expected to have basic computer literacy skills;
 - b. Pursuant to DepEd Order 55, s. 2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program, and in compliance with Executive Order 112, s. 2020 and AITF Resolution No. 79, only ALS completers who are 15 to 65 years old are allowed to take CB-A&E test, except for persons with immunodeficiency, comorbidity or other health risks and pregnant women.;
 - c. Applicants must have a Learner Reference Number (LRN) and at least 28 points in their presentation portfolio to be eligible to register in the 2020 CB-A&E Test.;

- d. Registration requirements are as follows:
- i. Original and photocopy of Certification of ALS Program Completion issued by the Learning Facilitator (For ALS Learners only);
 - ii. Original and photocopy of Birth Certificate issued by the Philippines Statistics Authority (PSA) formerly National Statistics Office (NSO);
 - iii. If copy of Birth Certificate from the PSA/NSO is not available, any of the following documents can be presented: Baptismal Certificate; Voter's ID (with picture, signature and date of birth); Valid Passport; Valid Driver's License; and any legal document bearing the applicant's picture, name, signature and date of birth (e.g. NBI Clearance, Police Clearance);
 - iv. Marriage Certificate for married women;
 - v. Two 2x2 identical Photo (white background with name tag, Last Name, First Name, Middle Name);
 - vi. Presentation Portfolio Assessment;
 - vii. Medical Declaration Form
4. Those applicants who opt not to take CB A&E test may subject themselves to the paper and pencil test on April, subject to IATF rules and guidelines.
5. Final schedule of CB-A&E Test, including the designated testing Centers and Room Examiners will be released on a separate Memorandum.
