**CONDUCT OF COVID-19 SWAB TESTING AMONG DEPED PERSONNEL**

1. As an integral part of the strategies in combating COVID-19 based on the Inter-Agency Task Force (IATF) and specific mitigation measures in schools and offices in the Department of Education (DepEd), this Office announces the **conduct of COVID RT-PCR testing among DepEd Cavite Division Personnel** which will be facilitated by the Cavite Provincial Health Office through their Provincial Epidemiology and Surveillance Unit (PESU).
2. The COVID-19 swab testing will be done on **February 10, 2021 at the General Emilio Aguinaldo Memorial Hospital (GEAMHS), Cavite Collaboration Center for Public Health Center Building, from 8:00 AM to 10:00 AM only.**
3. SDO personnel who volunteered to undergo COVID-19 Swab Testing are required to do self-quarantine but may continue to work at home until official negative results are out (**Please see attached Annex A**). However, in case of a positive result, current and relevant guidelines of the Department of Health (DOH) will be applied and immediate disinfection of high-risk areas in the office and contact tracing will follow. Health personnel from medical unit will assist in the conduct of the SWAB test activity.
4. Data Privacy and strict confidentiality will be observed.
