IMPLEMENTATION OF CAVITE SBS DOTS (DIVISION ONLINE TICKETING SYSTEM)

- In order to provide a more efficient and timely LIS assistance, this office thru
 the Planning and Research Section is implementing the utilization of DOTS (Division
 Online Ticketing System) to all public and private schools under this division.
- DOTS is an online system that allows the School Heads/LIS Coordinators to send online LIS inquiries and other service requests which require Central Office level of approval such as follows:
 - RF01 LRN Merging
 - · RF02 LRN Reactivation/Enrolment with Data Issue
 - RF04 Un-merging LRN (For twin learners)
 - RF10 Merging of School ID
 - RF12 Reopening of School Enrolment
 - RF13 Correcting Transfer Related Issues
 - RF14 Confirm Transfer from Closed School
 - RF15 Unenrollment of Learner
 - RF16 Updating of SHS Program Offering for Schools Abroad
 - RF17 COC Updating for Schools Abroad
 - Correction of Date of First Attendance (Request Letter signed by SH)
 - Correction of Tagging of Temporary Enrolled Learners (Request Letter signed by SH stating the reason of why the school enrolled a learner with no proper document)
- All requesting Public and Private Schools are enjoined to send requests thru DOTS using the link bit.ly/SBS_DOTS ensuring the completeness of all documentary requirements stated in the forms.
