VIRTUAL CONSULATION ON THE ENROLLMENT

PROCEDURES FOR SY 2021-2022

DATE:

08 June 2021

Amid the fight against the COVID-19 pandemic, DepEd remains committed to realizing the constitutional right to education by ensuring the continued provision of accessible, quality, and liberating education to all Filipino learners going into SY 2021-2022. In its new Basic Education Learning Continuity Plan (BE-LCP), DepEd puts a greater emphasis on different learning modalities such as blended learning, distance learning, and homeschooling, among others.

Despite the shift towards these modalities, the enrollment of learners and collection of enrollment data remains an essential DepEd function. Successfully implementing these modalities requires not only updating existing learner data but also collecting new types of data in order to facilitate planning, resource allocation, policy formulation, and intervention development.

In this light, DepEd shall be implementing again a modified regular enrollment process for SY 2021-2022 which shall take into consideration the health and safety of learners, parents, teachers, and other school personnel. Thus, the Department is currently improving the processes and procedures from last school year's enrollment.

To firm up the contents of the draft guidelines, a virtual consultation with select **DepEd personnel and other stakeholders shall be conducted.** Particularly, the consultation seeks to:

- Understand the experience of teachers, SDOs, and ROs in the implementation of DO 8, s. 2020;
- 2. Improve the enrollment procedures for SY 2021-2022 by identifying gaps and challenges from last year's enrollment; and
- 3. Determine the appropriate policy intervention and/or support mechanism to the stakeholders.

In this regard, selected participants, as per Annex, are requested to coordinate with the PS-ODir through email address <u>ps.od@deped.gov.ph</u> in order to confirm participation and laterally coordinate the schedule of the activity.
