

VARIOUS RESEARCH ANNOUNCEMENTS AND OTHER REITERATIONS

Pursuant to DepEd Order No. 16, s. 2017 (DepEd Research Management Guidelines [RMG]), Division Memorandum (DM) No. 128, s. 2020 (Winners in the 4th CARE CON), DM No.178, s. 2020 (Division RMG), DM No. 194 and 289, s. 2020 (Addenda and Corrigenda to the DM No. 178, s. 2020), DM No. 138, s. 2021 (Addenda to DM No. 368, s. 2020), and DM No. 304, s. 2021 (Timeline of Research Activities), this Office releases various research announcements and other reiterations related to the smooth implementation of the 2021 Division Research Agenda.
