GUIDE ON FILLING OUT THE ONLINE GOOGLE SHEET

Whereas "Clubs" and "Organizations" is differentiated as follows:

Clubs – a group of students organized with a similar interest for a social, literary, athletic, political, or other common purpose (example: Basketball Club, Photography Club, Math Club, etc.)

Organizations – a group of students organized for and acting toward a particular cause (example: Barkada Kontra Droga, YES-O, etc.)

And whereas "Co-Curricular" and "Extra-Curricular" is differentiated as follows:

Co-Curricular – clubs/organizations that are usually complementing the regular curriculum (example: English Club, Science Club, Math Club, etc.)

Organizations - clubs/organizations that are not tied to the curriculum (example: Barkada Kontra Droga, YES-O, etc.)


