ADDENDA TO THE GUIDELINES FOR THE CONDUCT OF SCHOOL GENDER AND DEVELOPMENT SENSITIVITY TRAINING (GST)

- 1. Anchored on the **DepEd Order No. 63, s. 2012** titled Guidelines on the Preparation of Gender and Development (GAD) Plans, Utilization of GAD Budget, and Submission of Accomplishment Reports, addenda to **DM No. 226, s. 2023** titled Call for Submission of School Gender and Development Proposals, this Office informs of the additional Guidelines for the Conduct of School Gender and Development Sensitivity Training (GST).
- 2. The schools may now be allowed to hold its GST anywhere else outside of CALABARZON, excluding those that are accessible by air or sea.
- 3. Schools may supplement their GAD budget with funds from the canteen or the local government, if the 5% MOOE is insufficient.
- 4. Reiteration of the Tour Provider declaration in the proposal, when applicable. However, the schools must not commit to any tour provider until the consent of the Schools Division Superintendent has been obtained.
- 5. Physical, mental, and health fitness, including equipment purchases and recreation, religious and cultural initiatives, construction expenses, supplies and materials for public use, study tour, Christmas and year-end celebrations and meetings cannot be charged to the GAD Fund unless they are clearly addressing specific gender concerns.
