PREPARATIONS RELATED TO THE REGIONAL MONITORING OF THE STATUS OF THE APPROVED BASIC EDUCATION RESEARCH FUND (BERF)-FUNDED PAPERS

- 1. In line with the **Regional Memorandum No. 379, s. 2023**, titled "Monitoring of the Status of the Approved Basic Education Research Fund (BERF)-funded Papers" and the agreements from the emergency meeting (**Notice of Meeting No. 144, s. 2023**) with the Municipal and City Research Committees (MRCs) and Cavite Association of Research Educators (CARE) District Level officers, this Office announces the preparations for the said activity.
- 2. To ensure effective monitoring and provision of technical assistance, the status of all 8th cycle BERF-funded papers will be overseen by their respective MRCs. In order to facilitate this process in a timely manner, the MRCs are offered two options.
- 3. The first option involves onsite monitoring. A designated MRC representative will visit the school of the grantee on either July 21 or 24, 2023. During the visit, the MRC representative will assess the progress of the research and provide relevant technical assistance to the researcher.
- 4. The second option entails online monitoring. Researchers are required to complete the online monitoring tool by July 21, 2023. Subsequently, the MRC representative will use the online technical assistance guide to provide suggestions and recommendations to the researcher through online communication channels no later than July 24, 2023.
