

For the information and guidance of all concerned, enclosed is a copy of Commission on Elections (COMELEC) Resolution No. 10057 dated February 11, 2016 entitled **General Instructions for the Boards of Election Inspectors (BEI) on the Testing and Sealing of Vote Counting Machines (VCMs) and Voting, Counting and Transmission of Election Results in Connection with the 09 May 2016 National and Local Elections.**
2. The said COMELEC Resolution provides for the rules and general instructions on the process of testing and sealing, voting, counting, and transmission of election results.
