**EXTENSION OF THE DEADLINE FOR SUBMISSION OF REQUIREMENTS
FOR THE ANNUAL PHYSICAL EXAMINATION OF DEPED CAVITE
TEACHING AND NON-TEACHING PERSONNEL**

1. **DepEd Order No. 11, s. 2020**, titled “*Revised Alternative Work Arrangements (AWA) on the Department of Education During the Period of State of National Emergency Due to COVID-19 Situation*” reiterates that Work From Home arrangement is still highly recommended for both Teaching and Non-teaching personnel. In addition, DepEd Office of the Undersecretary issued **DM-PHRODFO-2020-00198** clarifying that physical reporting to the workplace/onsite, shall be highly discouraged even in low-risk areas. Furthermore, the health and safety conditions and travel/border limitations of personnel, as enumerated in **DM No. 043, s. 2020** shall be given the utmost consideration.
2. Anent to this, the set deadline for the submission of Required Laboratory Examination Results for the APE shall be **extended until August 7, 2020**. Submission of aforesaid APE requirements **SHALL NOT BE IMPOSED AS URGENT** during this time of a global pandemic.
3. Moreover, the Medical Unit is continuously looking for the best possible means for the safe conduct of the actual APE. Please stand by for the schedule of APE per district and/or school which shall be posted in another issuance.
