DEPED CAVITE TV-BASED INSTRUCTION VIA NAIC CABLE TV

1. In view of the Distance Learning Approaches in the New Normal, DepEd Cavite will launch its TV-Based Instruction via Naic Cable TV on **October 5, 2020** and will continuously air various video lessons everyday from 8:00 AM to 5:00 PM during the school-year 2020-2021.
2. All public elementary and secondary teachers are hereby enjoined to submit their video lessons and other audiovisual educational materials to their respective learning area supervisors **until September 28, 2020**.
3. Submitted materials shall be selected and quality assured by the Learning Resources Management Section and the respective learning area supervisors to ensure congruence to the Most Essential Learning Competencies released by the Deped Central Office. Education Program Supervisors shall upload the quality assured materials to the Google drive link provided by the LRMS.
4. Quality assured materials submitted until September 28, 2020 shall be aired from October 5 to 9, 2020 and may be accessed by households within Naic, Maragondon, Ternate and Tanza, with subscription to Naic Cable TV.
5. Schedule and listing of the subjects to be aired for said week and deadline of submission of materials for the following weeks shall be released through a separate Memorandum.
