**PRE-REGISTRATION TO THE BREAK THE SILENCE: CHILD PROTECTION
E-LEARNING TRAINING PROGRAM FOR EDUCATORS**

1. Cognizant to DepEd Order No. 001 s. 2020 titled, "**Guidelines for NEAP Recognition of Professional Development Programs and Courses for Teachers and School Leaders**", this office through the Human Resource Training and Development Section in partnership with Stairway Foundation Inc., a NEAP Authorized Learning Service Provider, will be conducting the **Break the Silence: Child Protection E-Learning Training Program for Educators** from July 18 – September 9, 2022 via Stairway's e-learning platform.
2. Stairway's "Break the Silence: Child Protection e-learning training program for Educators" will be delivered online through asynchronous online learning modality, utilizing a series of self-paced interactive courses, together with recorded video-based lessons delivered by Stairway and the Department of Education.
3. The participants of this course are expected to have increased capacity to integrate child protection education into their everyday teaching, increased capabilities to identify any potential child protection concern of learners, and a better understanding of the various DepEd child protection prevention mechanisms and response protocols.
