

**PROVISION OF TECHNICAL ASSISTANCE FOR THE CONTINUOUS
 IMPROVEMENT OF SCHOOL PRACTICES RELATIVE TO
 SCHOOL-BASED MANAGEMENT**

1. This is with reference to DepEd Memorandum No. 75, s. 2022 entitled, "Moratorium on the Conduct of Division and Regional School-based Management Validation Activities" which states that all ongoing and planned activities relative to the conduct of validation process for the purpose of determining the SBM Level of Practice by the schools division offices shall be held in abeyance.
2.
